



You May Have Noticed A New E-mail From Us

Have you seen the "new" logged in reminder email yet? It's actually not new, and long time users may recognize this email from yesteryear. The notification had been disabled for a while, and now has been re-enabled. If you are still logged in to a tool at the end of your reservation, you will automatically receive this message:

This is a friendly reminder that you were still logged into the TOOL as of TIME on DATE. We send this reminder if your reservation ends but you are still logged into the equipment. If you have since logged out, or intended to be logged into the equipment at the time this email was sent, there is no action necessary on your part. If you forgot to logout, you can logout at the TUMI computer, or you may reply to this email and indicate your intended logout time.

This message is autogenerated, and is meant to serve as a reminder to you, **no action is required if you are intentionally still logged in and using the tool**. You only need to email us if you receive this message **and** you believe you had logged off before the end of the reserved time, **or** you believe you forgot to log off at the end of your use and you cannot return to log yourself off at the TUMI kiosk station.

Has the heat got you second guessing if you actually logged off a tool? You can check your user panel! Near the bottom you'll see your active logins, here you can double check if you are still in fact logged into a tool.


Safety Side Note:
